- (For PURCHASE request): Listing sheet, fully executed “Offer to Purchase” and/or “Purchase and Sales Agreement” (to include the legal description and copies of all applicable deposit checks)
- (For REFINANCE request): Current deed, most recent real estate tax bill and “Declaration” page from current homeowner’s insurance policy

INCOME (AS APPLICABLE)

- Two (2) most recent year-to-date pay stubs and past two (2) years’ W2s
- Award letters (social security, pension, other) to include proof of receipt (direct deposit, copies of checks, etc.)
- Leases or tenant-at-will agreements, if rental properties are owned
- Written evidence (court order, divorce decree) of additional sources of disclosed income (i.e. child support, alimony, etc.)*

If self-employed (files schedule C or 25% or greater ownership interest in employing company, or commissioned income or owner of additional rental property, etc.)

- Most recent two (2) years’ signed and completed personal federal tax returns (including all schedules)
- Most recent two (2) years’ signed and completed federal partnership or corporate tax returns
- Signed and dated year-to-date profit and loss statement and balance sheet
